LIABILITY WAIVER, RELEASE OF CLAIMS, AND ASSUMPTION OF RISK

PLEASE READ THIS DOCUMENT CAREFULLY. BY ACCEPTING THIS WAIVER, YOU ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE [NEW AMSTERDAM CAFÉ (YEG) INC.].

1. Acknowledgment of Voluntary Participation

I hereby acknowledge that my entry into **New Amsterdam Café Edmonton** (referred to as the "Lounge") and my participation in the consumption of cannabis, cannabis-infused products, or exposure to second-hand cannabis smoke or vapor are entirely voluntary.

2. Assumption of Risk

I understand that consuming cannabis involves inherent risks, which can vary from person to person. By entering the Lounge, I explicitly assume all risks associated with:

- **Physiological Reactions:** Adverse physical or mental reactions, including panic attacks, anxiety, rapid heart rate, paranoia, dizziness, nausea, or interactions with personal medications.
- **Overconsumption:** Delayed onset effects of edible or consumable products, which may lead to accidental overconsumption.
- **Second-hand Exposure:** Exposure to airborne cannabis smoke, particulates, or vapor, even if I choose not to personally consume cannabis.
- **Impairment:** Altered judgment, motor skills, coordination, and perception of time.

3. Safe Transportation and Impairment Agreement

- I agree that I will not operate a motor vehicle, heavy machinery, or any dangerous equipment while impaired by cannabis.

- I certify that I have arranged for safe alternative transportation (e.g., rideshare apps, public transit, or a designated sober driver) to exit the premises safely.
- I accept full liability for any actions, accidents, or damage I cause to myself or third parties after leaving the Lounge due to my impairment.

4. Code of Conduct & Right to Refuse Service

- I agree to comply with all Lounge house rules, staff instructions, and local ordinances.
- I will not bring any illicit, non-cannabis controlled substances onto the property.
- I understand that the Lounge staff reserves the right to refuse service, limit individual consumption, or remove me from the premises at any time for displaying signs of over-intoxication or disruptive behavior.

5. Waiver and Release of Liability

To the maximum extent permitted by law, I, on behalf of myself, my heirs, executors, and administrators, hereby release, waive, acquit, and forever discharge **[NEW AMSTERDAM CAFÉ (YEG) INC.]**, its parent companies, affiliates, owners, officers, employees, and agents from any and all claims, demands, damages, lawsuits, or liabilities arising out of my presence at or consumption within the Lounge. This includes, but is not limited to, claims of personal injury, illness, emotional distress, or property damage resulting from the negligence of the Lounge or its staff.

6. Governing Law

This agreement shall be governed by, construed, and enforced in accordance with the laws of the Province of Alberta without regard to its conflict of law principles. If any section of this waiver is found invalid by a court, the remaining sections will continue in full force and effect.

BY SIGNING UP FOR THIS MEMBERSHIP, I CERTIFY THAT I AM AT LEAST 18 YEARS OF AGE, HAVE READ AND FULLY UNDERSTAND THIS WAIVER, AND VOLUNTARILY AGREE TO ITS TERMS.
